

## Report on DentPAC Board of Directors

To: House of Delegates  
September 2025

DentPAC is organized dentistry's state-level political action committee. One of DentPAC's primary roles is to support candidates for Washington legislative and statewide office who support the dental profession. Contributions are determined by DentPAC's Board of Directors on a non-partisan basis upon the recommendation of WSDA lobbyists, staff, and grassroots dentists familiar with both the candidates and local political landscapes. DentPAC also supports WSDA's grassroots lobbying efforts.

DentPAC Board. The DentPAC Board of Directors (Board) consists of up to nine members who are recommended by a simple majority of the Board and appointed by the WSDA Board of Directors. The Chair and Vice Chair of DentPAC are also appointed by the WSDA Board of Directors. Board members serve two-year terms and are responsible for the supervision and control of the affairs and funds of DentPAC as well as establishing and carrying out all of DentPAC's policies and activities. In addition, Board members are responsible for the following duties:

1. Making recommendations for contributions to state legislative candidates;
2. Working with local grassroots dentists to obtain information on legislation and candidates for elected office; and
3. Soliciting contributions to DentPAC.

DentPAC Finances. As of **August 4, 2025**, fiscal year-to-date DentPAC received **\$229,681.39** in monetary contributions and the month-end cash on hand has decreased to **\$77,036.89**. Campaign finance laws in Washington state are \$1,200 for primary elections and \$1,200 for general elections. Statewide candidate contribution limits are \$2,400 for primary and general elections.

DentPAC Management and Reporting. DentPAC receives over 4,000 individual contributions from WSDA members on an ongoing basis throughout the year. Each contribution is transferred from WSDA to DentPAC and reported to the PDC. Political action committees in the State of Washington are required to report all incoming and outgoing contributions to the PDC.

The C3 report, which records all contributions made to a political action committee, must be submitted within five business days of receipt of the contribution. The C4

report, which records all contributions made by a political action committee to a legislative or statewide candidate, committee, initiative or other political action committee, must be submitted on a monthly basis.

In certain instances, such as months preceding an election, the PDC may require multiple C4 submissions in a month. DentPAC is also required to submit C6 reports for candidates who receive independent expenditures (direct mailers, radio spots, television advertisements, etc.) with PAC funds. C6 reports must be submitted within 24 hours of the date they are disseminated to the public.

Contribution Methodology. DentPAC funds are dispersed on a non-partisan basis to both legislative and statewide candidates as well as other political action committees. DentPAC generally makes contributions on several criteria including a candidate's position on dental issues; matters related to the management of a dental practice; relationship with WSDA dentists and lobbyists; committee assignment; and likelihood of the candidate winning their election. Each contribution requires a majority vote from the DentPAC Board of Directors. Following the 2015 legislative session, the DentPAC Board of Directors instituted a candidate questionnaire designed to educate legislators and gain an understanding of their positions on dental related issues. This is an additional tool for the Board to utilize when determining candidate contributions. The questionnaire was updated by the Board in May of 2024 and is included in Appendix A.

2025 State Election Campaign Contributions. The 2025 election cycle is an off cycle election year, meaning only certain seats in the state senate and house representatives are up for election. This year that includes the 26<sup>th</sup> LD senate seat and the 33<sup>rd</sup> LD house position 1 seat, among other races.

## **CANDIDATE QUESTIONS**

### **1. Insurance Practices**

WSDA believes that dentists should not be subject to punitive actions by insurance carriers that threaten the viability of independent practices when they decide to leave a network. Would you support efforts to prevent carriers from taking measures that result in an anticompetitive dental benefits market, as described in 2024 [SB 6218](#) and [SB 6307](#)?

**For over a decade, health care costs have risen while reimbursement rates for providing that care have shrunk.** Since 2011, Delta Dental of Washington, Cigna,

and Premiera - **three of Washington's largest dental insurance carriers** - have all enacted dental reimbursement rate reductions of between 15-25% across their networks. Over that same period, the expenses of operating a dental practice have increased 35% according to the Bureau of Labor Statistics. Would you support cost of living (inflationary) adjustments to contracts between carriers and providers, including dentists, as described in 2023 [HB 1655](#)?

## **2. Workforce Shortage**

Washington state is facing a severe shortage of dental hygienists and patients are waiting months to receive preventive care. Would you support efforts to create a new oral health workforce provider level focused on providing preventive dental care to patients, as demonstrated in 2024 [HB 2176](#)?

## **3. Dental Medicaid**

Would you support the expansion of adult and or pediatric dental Medicaid reimbursement?
